

Terms & Conditions Governing the TravellerShield Plus Insurance Policy Promotion with DBS Woman's Card and POSB Everyday Card ("TSP x WMC x PED Promotion")

- 1. Participation in the TSP x WMC x PED Promotion constitutes acceptance of these Terms and Conditions.
- 2. The TSP x WMC x PED Promotion is jointly organised by DBS Bank Ltd ("**DBS**") and Chubb Insurance Singapore Limited ("**Chubb**") (collectively, the "**Organisers**"). TravellerShield Plus Policy is underwritten by Chubb and distributed by DBS.
- 3. The TSP x WMC x PED Promotion will run from 1 May 2024 to 31 May 2024 (both dates inclusive) ("**Promotion Period**").
- 4. To be eligible for the TSP x WMC x PED Promotion, customer ("Eligible Cardmember") must:
  - a) purchase a new TravellerShield Plus Single Trip or Annual Plan insurance policy ("Policy") via the DBS/POSB website, DBS PayLah! App, DBS digibank or at any DBS/POSB branch with a DBS Woman's Card or a POSB Everyday Card ("Eligible Card") during the Promotion Period;
    b) be one of the Insured Persons of the Policy;
  - b) be one of the insured Persons of the Policy,
     c) enter 'WMCTRAVEL' in the Promo Code field if you are a
  - c) enter 'WMCTRAVEL' in the Promo Code field if you are a DBS Woman's Cardmember ("WMC Promo Code"); or enter 'PEDTRAVEL' in the Promo Code field during online application if you are a POSB Everyday Cardmember ("PED Promo Code");
  - d) have the application and insurance premium payment accepted by Chubb during the Promotion Period;
  - e) you must not have cancelled any existing TravellerShield Plus Policy between 1 April 2024 to 31 May 2024 (both dates inclusive); and
  - f) the commencement date of the Policy is between 1 May 2024 and 30 June 2024 (both dates inclusive).

Notification EDM will be sent by Chubb's appointed vendor (with sender email address: <a href="mailto:chubb\_rewards@reward360.sg">chubb\_rewards@reward360.sg</a>). In the event that an email address is not indicated during the application of the Policy, Eligible Cardmembers will receive the Vouchers via an SMS ("Notification SMS") at the mobile number indicated during the application of the Policy.
- 9. All Eligible Cardmembers will be notified by 30 September 2024.
- 10. The Vouchers must be utilised before the expiry date stated in the Notification EDM or Notification SMS. The Organisers are not obliged to replace any Vouchers that are not received, have expired or which have been misplaced.
- 11. In the unlikely event that that Vouchers become unavailable, the Organisers reserve the right to replace the Vouchers with items(s) of similar value without prior notice.
- 12. The Premium Discount and Vouchers are non-exchangeable for cash and non-transferrable.

Each Eligible Cardmember's card account ("**Card Account**") must not be closed or suspended and in good standing (i.e. to abide by the terms and conditions listed in the <u>DBS Credit Card Agreement</u>) throughout the Promotion Period and at the time when Premium Discount and Vouchers are being awarded.

<u>Terms & Conditions Relating to the TravellerShield Plus x Sweeter Deals Promotion ("TSP x</u> <u>Sweeter Deals Promotion")</u>

- 1. The TSP x Sweeter Deals Promotion is organised by DBS Bank Ltd ("DBS").
- 2. TravellerShield Plus is underwritten by Chubb and distributed by DBS.
- 3. A customer ("**Eligible Customer**") will be allocated with Lucky Draw Chance(s) ("**Draw Chance**") and cashback reward ("**Reward**"), on top of the Premium Discount and Vouchers, if:
  - a) policyholder registers for Sweeter Deals via the <u>Sweeter Deals Promotion website</u> before or on the same day as buying a Policy during the Promotion Period;
  - b) policyholder did not cancel any existing Policy between 1 April 2024 to 31 May 2024 (both dates inclusive); and
  - c) the commencement date of the Policy is between 1 May 2024 and 30 June 2024 (both dates inclusive).

- 13. The maximum Reward that an Eligible Customer can receive on TravellerShield Plus Insurance is S\$10 for Single Trip plans and S\$100 for Annual Multi-Trip plans. If an Eligible Customer has purchased multiple policies, we will take the aggregated premium amount for calculation
- 14. The Prize is non-exchangeable for cash and non-transferrable. The Reward is non-transferrable.
